Notes

This form can be used to apply for minor amendment to details / ownership of a licence such as:

- Adding or removing a land parcel to a licence.
- Adding or changing secondary contact details to a licence.

At least one existing party and parcel must be retained on the licence for this application form to apply. (Changes of both land and licence ownership require a transfer application to be made. If unsure please contact Melbourne Water.)

Application fees apply to adding or removing parties or parcels and for company name changes.

No fee will apply to changes in name due to changed marital status, postal or secondary contact details.
