Bushfires	Melbourne Water staff	<ul> <li>Visits will be cancelled in the event of an "Extreme" or "Catastrophic" fire danger rating or a Total Fire Ban weather forecast.</li> <li>Emergency evacuation plans will be implemented.</li> </ul>
Avian Influenza	All visitors	<ul> <li>All visitors advised to avoid contact with wild birds or wildlife and maintain good hand hygiene.</li> </ul>
COVID Safety	All visitors	<ul> <li>Everyone is to adhere to the Stay Safe Directions (Victoria) currently in force <u>Pandemic Order Register  </u> <u>health.vic.gov.au</u></li> <li>No-one is to visit when unwell. Potential for microbial infection	Melbourne Water staff	<ul> <li>Site safety briefing prior to bus tour.</li> </ul>	
	Teachers / Adults	<ul> <li>All visitors should:</li> <li>Ensure any open wounds are covered.</li> <li>No eating or drinking during the bus tour.</li> <li>Wash hands with soap and water at the end of the tour.</li> </ul>	
Exposure to sun, wind and rain	Teachers / Adults	<ul> <li>Application of sunscreen and the wearing of hats and/or raincoats are recommended.</li> <li>Group will stay in bus during inclement weather.</li> </ul>

Bus breakdown	Melbourne Water staff	<ul> <li>Adherence to instructions from Melbourne Water staff.</li> <li>If people need to exit the bus, make sure it is safe before proceeding.</li> </ul>	
Chlorine Leak	Melbourne Water staff	<ul> <li>An alarm will sound in the event of a chlorine leak.</li> <li>All Melbourne Water staff have been site inducted and are aware of chlorine leak procedures/ emergency plan.</li> <li>Direct bus away (map of evacuation points attached).</li> </ul>	
Injuries caused by heavy objects	Melbourne Water staff	<ul> <li>Safety briefing by Melbourne Water staff at the start of the activity.</li> </ul>	
	Teachers / Adults	<ul> <li>Supervision of students always.</li> </ul>
